## General terms and conditions

### § 1 – Selling

1. It is not allowed to sell items, which violate the law, particularly the copyright (pirated copy, pirated printing etc.). The sale of foodstuffs is generally forbidden.
2. Self-made and produced items may be sold, if the sale does not violate applicable law, particular copyrights.
3. A maximum of 15 items may be offered for sale. Trading Cards (for example Yu-Gi-Oh!, Magic) are only allowed to sell as booster packs, decks, etc. at the Bring&Buy, not as single cards.
4. Bundles (a combined offer of more than one item) we are considered as one article. However, they must tied together / attached to each other in some way by the seller in advance.

Example:

You sell of a manga series the manga 1 - 4. If you sell them individually, they are they are considered as four different articles. But if you sell them bundled, they are considered one.

5. Goods with age limits will sell only to people, who providing proof of age.
6. You need to label all your items in advance with the selling price and your seller number.

7. The seller determines the prices to which his belongings will sell, however they must always be rounded up to ten's digits.

Examples of permitted sale prices: 2€ - 6,50€ - 3,10€  
- 8,30€  
Examples of prohibited sale prices: 1,99€ - 4,75€ -  
7,48€

8. For all articles from a selling price of 2€, we charge a sales fee of 10% (we use to cover our costs). Children and adolescents under the age of 16 generally do not have to pay any fees.
9. For theft damages and damages to the articles at the Bring&Buy the organizers bear the damage.
10. We reserve the right to exclude articles from sale.

## § 2 – Handing over and collection

1. The articles can be delivered up to one hour before closing time at any time during the opening hours (2 pm – 7 pm) of the Bring&Buy. All articles must be submitted simultaneously together with the registration form.
2. The articles and the money for sold stuff may be picked up every time during the opening times of the Bring&Buy and until 30min after (2 pm – 7.30 pm). All unsold items and the money for sold stuff (cash payout only) can only be picked up together.
3. For the collection you have to provide a proof of identity (e.g. ID, driver's license, pupil ID).
4. The collection of your belongings by another person is only possible by a certificate of authority (e.g. identity card, driving licence, pupil's card)
5. Unsold articles basically have to be taken back. If for any reason something will not be taken along, it is possible to send the items back to the property owner by post. The shipping and packing costs borne by the respective property owner.
6. If after two months the property owner of an item had not contact us (for example by e-mail) or had not send the money for possible shipping and packaging costs, the item will be transferred to the property of the organizer.

### § 3 – Age restrictions

1. Anyone from seven years of age may sell things at the Bring&Buy.
2. Children and adolescents between the ages of seven and 15 also need an additional declaration of consent of the parents to sell articles at the Bring&Buy.

### § 4 – Limitation of liability

1. The Nishi Trade e. V. (registered association) is liable in accordance with the legal regulations for intent and gross negligence on the part of its legal representatives, volunteers or other vicarious agents. The same applies to the assumption of guarantees or other liability independent of fault as well as to claims under the Product Liability Act or in the event of culpable injury to life, body or health.
2. A further liability of the Nishi Trade e. V. (registered association), its legal representatives, volunteers and other vicarious agents is excluded.
3. Should single provisions of these GTC become partially or completely ineffective or void, this shall not affect the effectiveness of the remaining provisions.
4. The user agreement, including these GTC, is subject to German law.

### § 5 – Indemnity against liability

The seller discharges the Nishi Trade e. V. (registered association), its legal representatives, volunteers and other vicarious agents from all claims that other third parties assert against the Nishi Trade e. V. (registered association) for violation of their rights by offers and other contents posted by the seller by means of the services of the Nishi Trade e. V. (registered association) or because of their other use of the services of the Nishi Trade e. V. (registered association). The seller accepts the costs of the necessary defense of the Nishi Trade e. V. (registered association), including all legal fees and costs of the proceedings in the legal amount. This is not valid if the infringement is not the responsible of the seller. The seller is obligated to provide the Nishi Trade e. V. (registered association) immediately, truthfully and completely with all the
